In 2017 we presented "[HillFest](#)," However, the pandemic caused us to cancel 2020 & 2021 in-person, although we held our conference virtually so that we could keep the community connected. This year we've decided to go forward with an in-person festival and we want to ensure attendees implement all measures for safety. Please adhere to the below guidelines. We care about your safety.

**HILLFEST 2022 GUIDELINES:
STANDARDS OF HYGIENE + COVID-19 REMINDERS:**

- Cleanliness is extremely important.
 - Attendees are expected to uphold and demonstrate proper hygiene
 - Keep hands washed and/or sanitized.
 - Implement social distancing when necessary
 - Do not attend HillFest if you are sick
 - Do not attend HillFest if you do are still waiting on your test results.

1. All Covid-related health and safety protocols, measures, procedures and guidelines suggested or directed by the CDC are in effect as of the dates of the Festival. Refer to the CDC website for further details based on the Washington D.C. area. (location of HillFest)
 2. All applicable Covid health and safety protocols, measures and procedures required by any Federal, state or local government or government agency that apply to any of the Festival events or activities or to the venues or locations in which they are held.
 3. All requirements, procedures, protocols, measures or rules relating to health and safety set by any venue in which a Festival event or activity is held, including without limitation, any capacity limits, mask and social distancing rules imposed by any such venue.
 4. All Festival Attendees have the option to wear a face covering at every Festival event or activity (indoors and outdoors), except when actively eating or drinking in locations in which such eating or drinking is permitted.
 5. **Not Required At This Time:** Check for updates at [HillFest.org](#) and on the [CDC](#) website. At this time Festival Attendees are not required to present documentation of a negative RT-PCR test taken within 72 hours prior to HillFest check in. However, if updates by the CDC change and require test results for public events during the time of our festival dates this will be implemented.



If you have been diagnosed as positive for COVID-19, have been around someone with COVID-19 and are still waiting for your test results, or if you are currently experiencing the below symptoms, please avoid attending all HillFest events.

People with COVID-19 have had a wide range of symptoms reported – ranging from mild symptoms to severe illness. Symptoms may appear 2-14 days after exposure to the virus. Anyone can have mild to severe symptoms. People with these symptoms may have COVID-19:

- Fever or chills
- Cough
- Shortness of breath or difficulty breathing
- Fatigue
- Muscle or body aches
- Headache
- New loss of taste or smell
- Sore throat
- Congestion or runny nose
- Nausea or vomiting
- Diarrhea

This list does not include all possible symptoms. CDC will continue to update this list as we learn more about COVID-19. Older adults and people who have severe underlying medical conditions like heart or lung disease or diabetes seem to be at higher risk for developing more serious complications from COVID-19 illness.
